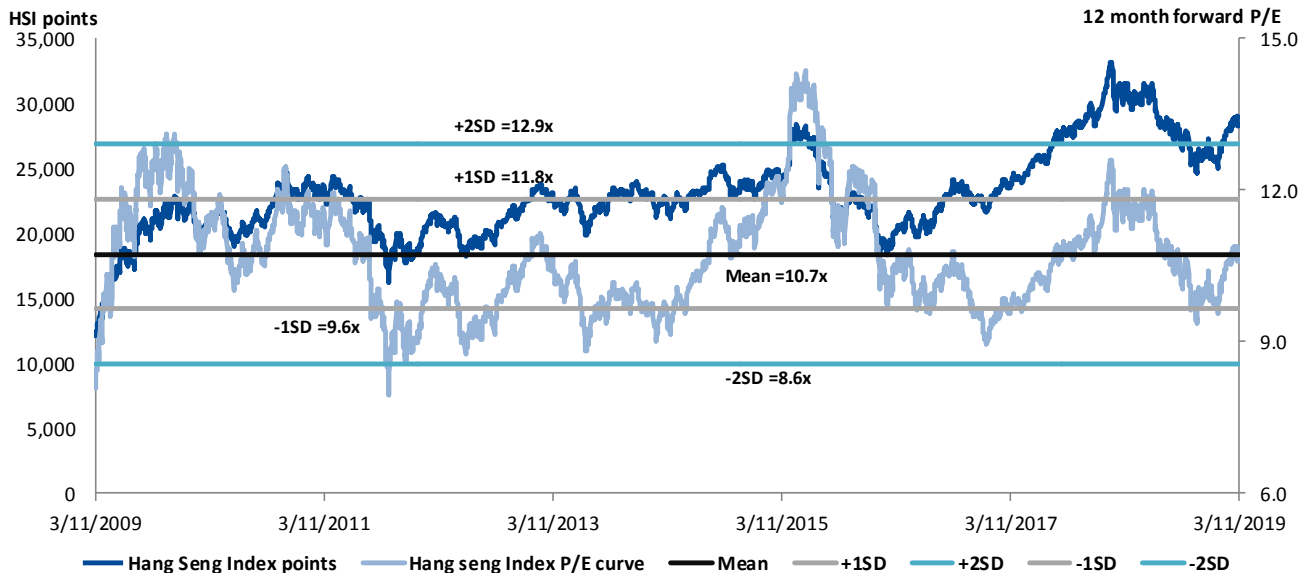

## HSI's FWD P/E hovers between 9.6x and 11.3x

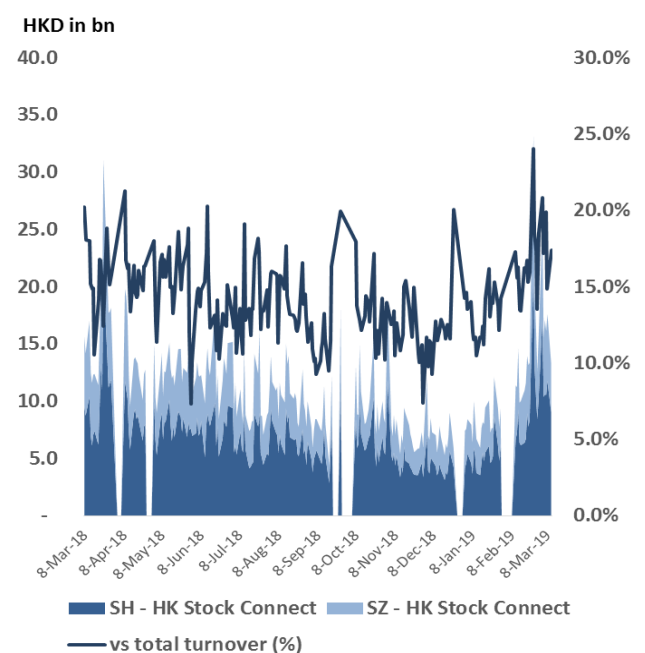
## Market Overview

Hang Seng Index closed up 1.0% at 28,503. Market turnover decreased to HKD 102.8bn. HSCEI climbed 1.1% at 11,277.

Southbound trading of SH-HK Stock Connect and SZ-HK Stock Connect attained HKD 9.0bn and HKD 4.2bn respectively, making up a combined 17.4% of total HK stock market turnover.

**On 10 years horizon, we see HSI will fall into a range between 9.6x to 11.3x 12M forward P/E(10.6x currently), which is equivalent to 25,500 to 30,000 points respectively. This is also equal to 1.0 standard deviation and 0.5 standard deviation below / above the past 10-year 12M forward P/E mean of 10.7x.**
